GBFB is Here to Help Those in Need

The mission of the Greater Berks Food Bank is to feed the hungry. That seems like it should be a simple task. However, in order to receive and distribute over 7,000,000 pounds of food GBFB must follow guidelines and regulations set by Feeding America, USDA and PA Dept. of Agriculture. In most cases, we have no flexibility when it comes to those requirements.

While we know it may not be convenient for our Agencies to perform Civil Rights training for their volunteers, get their monthly statistics in on time, come to Food Safety trainings, or get all your CSFP recipients recertified, these are all requirements in order for GBFB to continue to provide food to agencies. There may be times that we have to send stern emails or letters and actually have to suspend an agency for non-compliance, but because we don't want to stop agencies from feeding the hungry, we only do this after numerous reminders to get the proper information completed. GBFB is here to provide food to our agencies, who in turn are there to provide food to our hungry neighbors. In order to do this we all need to work together and stay in compliance with all State, Federal and National Food Banking guidelines to make the process work more efficient and timely so the food gets to those in need consistently.

Remember – we are all working for our hungry neighbors to put more on their plates!

CSFP Recertification

It's that time of the year again, all CSFP recipients (waiting list and active) need to be recertified. If you have yet to receive your recertifications, please contact Ashley Snyder ASAP. While completing recertifications, please remember that income MUST be verified; you can refer to your CSFP Binders with any questions regarding what is an acceptable "proof of income". In addition to the new income guidelines, there is also a new CSFP application. Throw away all old unused applications and add the new application to your CSFP Binder. Any new applicants that come in on old forms will be returned and the recipient will not be placed on the waiting list until a current application is submitted.

The order sheet is structured specifically to streamline the ordering process and helps us avoid ANY entry errors. It has come to our attention that there are many agencies who are not using the order sheet. In addition, any order that is submitted <u>MUST</u> have the Agency number, name, contact name, phone number, date and time for pickup or delivery. **Effective immediately**, any orders not submitted on the GBFB order sheet will be returned and not processed. The CSFP program is now allowing a CSFP Caretaker. What does this mean? The CSFP Caretaker does not have a formal definition in the regulations, but he/she would essentially be anyone who takes care of a **Home Bound Senior** (i.e.: a relative or friend responsible for assisting the person with his/her daily needs). Another year is winding down for our Weekender backpack program which seems unbelievable to me. Time has flown by and we have been able to provide a great variety of healthy items to include in their bags. At the highest point in the school year we were able to send home 1,441 bags of food in a week to children in our community. Surveys have been sent home to parents/guardians, the children and also our coordinators to hear feedback as to what we can improve or change to make the program better. We continue to fill the bags with healthy, kid friendly items, and include single serve as well as family size items. We currently have 14 school locations and one church location that takes part in the program. We thank the volunteers who help to coordinate the program at those locations and also those that help them to ensure the children receive the food each week. The requests to bring in new schools continues to grow but at this time

we have a waiting list until we obtain additional funding or we have a change in one of the current sites that are on the program. THANKS for a super year and we look forward to sharing our survey results.
